Message from the President

Are You an Advocate?

What is an advocate? In ancient times an advocate was someone "whose profession was to plead cases in a court of Justice." It comes from the Latin word advocatus—one called to aid; a pleader, advocate!

However, today advocacy has a more expansive meaning. It can mean speaking or working on behalf of an individual, a cause, an issue, or a combination of all three. Typically when we talk about advocacy, we automatically think of it in terms of legislative matters; whether it is budget issues or policy matters.

The truth is those of us who are working in the aging network are called to be advocates on numerous issues. This is especially the case if we are in leadership positions. And, wow, do we have some important issues needing

our support and advocacy. What are two of those important issues?

The first issue needing our advocacy is the Florida State Budget. We were thrilled when Governor Rick Scott's proposed budget for 2014-15 included an increase in General Revenue funding for aging programs, such as



the Community Care for the Elderly Program (CCE). It is encouraging that the Governor and his policy staff see and understand the continued role and importance of such programs, especially as we turn to the Medicaid Managed Long Term Care System for Medicaid clients.

Our advocacy for these General Revenue programs started several months ago when the leadership of FASP, FCOA, Florida Health Care Association and Robert Beck from PinPoint Results began meeting

with budget and policy staff to talk about these vital programs. Now our advocacy must continue with members of the Florida Legislature.

That is where you come in; each of you is being asked to contact the members of your local Florida Legislative Delegation in support of increased funding for Florida's General Revenue aging programs such as CCE. How to find your legislators?

We have an advocacy brochure for your use in these contacts which explains in layman's terms what these General Revenue programs do, who they help and why they are so important. Now is the time to be making these contacts at the local level with members of your delegation. *Click here - Advocacy Brochure*

If you personally cannot do that, perhaps some of your volunteers or members of your board of directors would be willing to help. What you have to say is important! You know the needs, you know your clients and you know the importance of these programs. Share that knowledge with your local legislative delegation.

The second issue of importance to all advocates in the Aging Network is the reauthorization of the Federal Older Americans Act (OAA), replacing the funding lost due to sequestration AND increasing the overall funding level of OAA.

Since its inception, OAA has formed the foundation of many home and community based services throughout our country. It has served as a model for many state programs, such as Florida's Community Care for the Elderly (CCE). It is playing an important role in the continuum of care and is helping millions to remain independent in their own homes and communities. Indeed, in Florida, it complements both the state General Revenue Programs and the Medicaid Managed Long Term Care Program. Yet the funding has never kept pace with the ever growing number of older Americans.

Just think, in 2030 it is estimated that some 25 percent of Americans will be age 60 plus! Equally important, as most of you who work in the Network know, OAA clients are more and more beginning to resemble clients in the CCE Program. They are increasingly frail, older and poorer. OAA and its programs are NOT "icing on the cake," they are often the difference between in home care and the need for institutional placement. In summary, OAA needs to be reauthorized, sequestration losses restored and overall funding increased!

Finally, remember this; elected officials want, and need, to hear from their constituents. They want, and need, to know what their constituents' opinion is on public policy issues and legislative matters. If there is "thundering silence" it is impossible for them to know your thoughts on issues of importance. You know, whatever your political persuasion is, all elected officials, at all levels of government, deserve our thanks for their willingness to "step up to the plate" and offer themselves to public service. It is not an easy task and few are willing to take on the challenges. They are often torn between (and among) competing priori-

ties, all of which may have great merit. They have many citizens making demands on them for their time, their action and their vote on a particular policy issue.

Those of us in the Aging Network should not be shy about letting elected officials and policy makers at the state and federal levels know how important these two foregoing matters are to the citizens we serve day in and day out. We need to "advocate" on these vital legislative issues for the sake of those we serve.

Senator Legg Fights for Seniors in Bipartisan Bill

Tallahassee, Florida – Florida Senator John Legg (R-Trinity) filed Senate Bill 1082 (Adult Day Care Centers), which will protect senior citizens and will provide for better quality of care. Representative Amanda Murphy (D-New Port Richey) has filed the companion legislation, House Bill 935 (Adult Day Care Centers).

"With every passing day, Florida's aging population expands," said Senator Legg. "There is a rapidly growing need for an array of senior care options, including adult day services. Senate Bill 1082 safeguards our seniors and creates additional opportunities to enhance their quality of life."

Senate Bill 1082 (Adult Day Care Centers) includes the following highlights:

- Defines the standards and purpose for adult day care services industry in Florida, which
 are non-residential and are a growing option in the long term and chronic care approaches
 in keeping healthcare costs down.
- Eliminates the exemption for an assisted living facility and other long term care settings to
 provide adult day care services without having to obtain an adult day care license, enabling them to have their own identity and not be diluted as an "add on" service within other
 industries.
- Provides for adult day care services that have been in operation for a minimum of one year, to relocate and continue operating the program when it requires a temporary move for improvement or repairs.
- Grants a conditional license if an organization that has been in operation for one year and
 in good standing, may move the entire center to a new location. A renewal application
 submission 60 days prior and site inspection by the agency would be required within 6
 months.
- Requires counties and municipalities operating an adult day care services program to pay license fees to be consistent with the industry.
- Protects vulnerable populations and the integrity of the programs and ensures that violators not be able to continue to operate if the Agency determines that corrections of violations have not been made and the safety or well-being of individuals are at risk.
- Requires annual updated education for staff for methods of care for Alzheimer's disease and related dementias rather than the current four hours of study for a lifetime of care.

Governor's Budget Recommendations for GR programs

Florida Law requires the Governor to present a balanced budget to the Florida Legislature for consideration during the legislative session scheduled to convene on March 4, 2014. During the 60 day session, the Legislature will review and consider the Governor's recommendations as they build the budget for next fiscal year.

For the first time in several years, the Governor's budget recommendations include increased funding for the General Revenue-funded programs Community Care for the Elderly - \$4 million and for the Alzheimer's Respite Care Program - \$4 million. This \$8 million recommended increase is to be used to reduce the number of seniors currently on the Department of Elder Affairs waiting list for assistance.

In addition, the Governor's budget also recommends an increase of \$8 million in General Revenue to match federal Medicaid funding for additional managed long term care program slots. Rounding out his recommendations, the Governor's budget provides \$650,000 in General Revenue to also match federal Medicaid funding to continue current Aging & Disability Resource Center (Area Agencies on Aging) funding for client assistance under managed long term care.

Daylight Savings Time begins March 9

Daylight Savings Time Can Negatively Affect Senior Health by Anne-Marie Botek

As the country prepares to "spring forward" an hour for daylight saving time on March 9th, it's important to keep in mind how even a tiny time change can affect your health—particularly if you're older or suffering from a chronic illness.

Dr. Mingone and Sharon Roth-Maguire, MS, RN, of BrightStar Care, offer some tips to help seniors adjust to the time change:



- Maintain sleep patterns. The time between falling asleep and waking up shouldn't vary by more than 20 minutes.
- Avoid caffeine, alcohol, over-the-counter sleep meds and do not take naps, especially during the first days of DST.
- Engage in a physical activity in the late afternoon or early evening. Roth-Maguire says that a hot, relaxing bath will have the same effect because the sun helps to regulate body rhythms.
- Make sure the bedroom is quiet, cool and dark enough to promote sleep.


