

About FASP

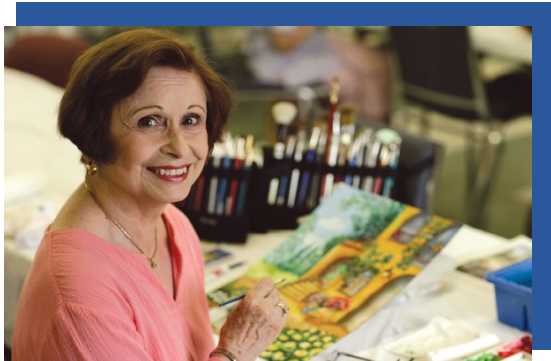
